PARISH ASSEMBLY

What is a Parish Assembly?

There can be, and often is, confusion between the Annual Parish Meeting and the Annual Meeting of the Parish Council. All Parish and Town Councils throughout England are required by law to hold an Annual Parish Meeting (which we have called the Parish Assembly to try and avoid confusion!), which must take place between 1 March and the 1 June (inclusive).

What is the purpose of the Parish Assembly?

The purpose of the meeting is to provide an opportunity for the Parish Council and other local organisations to explain what they have been doing over the last year. It also enables the electors to have their say on anything they consider is important to the people of the parish.

What else happens at the meeting?

This year and last year the Parish Council invited local clubs, societies and other organisations to provide an exhibition and/or have a stand at the 'market place' to showcase the work of their group.

Who can attend the meeting?

The Parish Assembly is a meeting for all the local government electors of the parish. It is not a meeting of the Parish Council. Anyone may attend but only registered electors of the parish may speak and vote during the meeting.

Will I be able to ask questions and make suggestions?

Any registered elector may ask questions of the Council, which will usually be answered by the Chair, the Clerk, or a councillor. An elector may also make suggestions and comment on anything pertinent to the people of the parish. This will be welcomed and is the whole purpose of the meeting.

Will notes be taken of the meeting?

Minutes of the proceedings of a Parish Assembly are recorded and will be signed at the next Parish Assembly.

Parish Update

- Playdale Activity Trail.

Lane: Warwickshire County Council have renamed this track as a U route. The Parish Council is yet to understand the full implications of this change. But as the route has an unknown status the County Council will not maintain or enforce this track as anything other than a footpath. It has now been established that the track and land adjacent, which has been so badly damaged by members of the off-road community, is owned by a local farmer. The Parish Council is making a direct appeal to the land owner and is waiting to hear the outcome.
