MINUTES	<p>July meeting Minutes agreed and signed by the Chairman</p>
ALCESTER SOUTH SNT	<p><b>OPEN FORUM:</b>          The following incidents have been reported in the period 15/7/19 – 15/09/19. These were:</p> <ul style="list-style-type: none"> <li>○ Suspicious Circumstances. Spernal Lane. Three scrambler bikes with a total of five people on them seen in the Heart of England car park. The riders had face coverings / balaclavas and it looked like they were parked around a vehicle. When they realised they were being watched they rode off.</li> <li>○ Vehicle Crime. Station Road. Man disturbed trying to break into van. Alarm activated.</li> <li>○ Theft. Henley Road. Four batteries stolen from hydraulic lift.</li> <li>○ Burglary Residential. Alne Hills. Following an Alarm activation, it was found that a door to the property had been forced. A Green Free Lander was seen driving away from the area at the time.</li> <li>○ Anti-Social Behaviour. Spernal Lane. Several motorcycles heard using one of the tracks off Spernal Lane. Generally being a noise nuisance.</li> <li>○ Road Incident. Great Alne. Report of two cars racing each other.</li> <li>○ Suspicious Circumstances. Pelham Lane. White Peugeot Expert van seen collecting scrap in the area. Driver described as male, medium build, 5' 8", wearing a red hoodie and ¾ length blue tracksuit bottoms. The last three letters of the registration number were 'JFO'.</li> <li>○ Suspicious Circumstances. School Road, Great Alne. Man seen standing on the patio area at rear of house. Man walked off when he noticed that he had been seen.</li> </ul>
UPDATE ON SPERNAL LANE DEVELOPMENT	<p>Linfoot Country Homes provided the following update after the meeting:</p> <p><i>“The development is nearing completion with all but two of the properties now handed over and occupied. Plot 5 will complete at the end of this month and plot 10 (which is reserved but not yet exchanged) should be handed over by mid-October. We are now preparing the roads for the tarmac wearing course which will be laid in the next 2-3 weeks and carrying out kerb and other remedial works. Planting, turfing and seeding works are also now in hand. Over the last few months we have been carrying out a vigorous programme of weed management to the communal areas which are to be seeded. This has involved several cycles of spraying the weeds to kill them, then allowing them to grow through before spraying again. The purpose of this is to limit the weeds as much as possible prior to seeding which ensures a much better-quality take and finish of the seed (though whilst it is going on it does look as if not much is happening for a lengthy period!). This is now complete and seeding will be taking place shortly together with all remaining turfing and shrub planting. The remaining bare root tree, hedge and native mix planting will take place when the bare root planting season starts which will be from late November onwards. This will include the hedge along Spernal Lane, the landscape buffer belt and most of the planting to the balancing pond area”.</i></p>
GREAT ALNE PARK UPDATE (FORMERLY	<p>Kelly Webb provided provided the following update for Great Alne’s Summer newsletter that were delivered at the beginning of September:</p>

MAUDSLAY PARK)	<p>The team at Great Alne Park would like to thank everyone who attended Parkfest on 20<sup>th</sup> July 2019. There was a fantastic turnout and the day was enjoyed by all.</p> <p>Great Alne Park are planning another music and dinner evening in September and more information will be provided soon. A Christmas menu will also be created soon.</p> <p>The Thursday themed evenings are going well and they have a steady number of people attending every week. Great Alne Park would love to see more residents each week. Please call to book your place.</p> <p>Sunday lunch is proving very popular and booking is a must! Bookings can be made by emailing Kelly or calling 01789 489103. If it is out of hours, there is an answerphone where booking requests can be left.</p> <p>Kelly regretfully informed us that Tina Digby is no longer the Village Manager. She resigned from this post in early August. Kelly said 'Tina will be greatly missed. She made such an impact on moving the village forward in such a positive way'.</p> <p>At the July meeting, Councillors agreed that they needed to re-establish communication with senior management at Great Alne Park. Cllr Mainwaring arranged a meeting and the following information was discussed/provided:</p> <p>The allotments are now ready. There are currently 18 in total. The village of Great Alne have a 50% allocation of these but they will be managed by Great Alne Park. Estimated rental costs of £25 per plot per year. Please contact Kelly Webb if you are interested in having an allotment. 7 of the 9 assigned to Great Alne residents have already been allocated.</p> <p>Transport requirements at Great Alne Park are minimal at the moment, with just a handful of residents making use of the service. They know this will greatly increase over time and be similar to their other villages where they have a full-time driver and a dedicated all-electric London cab. There are longer term plans but nothing will change for a while whilst demand is low.</p> <p>The gym and pool have re-opened to residents at Great Alne for a nominal monthly or annual fee. Please contact Kelly Webb for more information. They are making a large investment in the equipment, introducing eGym to the village, which will provide a much better option than the small facility at the moment.</p> <p>They are recruiting for a new Village Manager and will introduce the successful applicant to Great Alne Parish Council as soon as possible.</p> <p>Keith Cockell (Design Director Inspired Villages) and David Hamlet (Consultant of Performing Arts) attended the meeting to explain their future plans for Great Alne Park which they hope residents of Great Alne can share in. David Hamlet has been recruited to introduce a music culture to Great Alne Park. Activities envisaged include music events; book launches and poetry evenings, to give some examples. Understandably, the target audience is the residents of Great Alne Park but it is very much hoped that these things will appeal to residents of the village also. They want a multi-generational, cohesive approach that can appeal to all.</p> <p>Mr Cockell and Mr Hamlet would very much like to hear from residents should you have any ideas. Communication is open so please do get in touch if you have suggestions for them to explore.</p>
MEMORIAL HALL REP REPORT	<p>Cllr Mrs M Holding sent the following update following their June 2019 meeting.</p> <ul style="list-style-type: none"> <li>• Work on the new website continues – they hope to launch it this year</li> <li>• Fantastic attendance at the Village Summer BBQ with a healthy total of funds raised for the Hall</li> <li>• Dates for the diary: Saturday 30<sup>th</sup> November – Christmas Coffee Morning, Sunday 1<sup>st</sup> December – Christmas is coming and Saturday 7<sup>th</sup> December Christmas Supper</li> </ul>
REPRESENTATIONS FROM RESIDENTS	<p><b>Bus Service</b> – Several residents attended the meeting to express their frustrations with the lack of bus service this week. No buses have been running through the village. Whilst they appreciated the difficulties whilst the road works at Haselor were completed, these are now resolved but the buses have not returned to their normal routes. Some residents have contacted the bus companies but have not been provided with any useful information. County Cllr Rickhards was very disappointed to hear this and will contact the bus companies directly on behalf of Great Alne Parish Council to complain and find out further information. The Parish Council completely appreciate that the bus service is limited already and that residents rely on it to get to medical appointments and work. County Cllr Rickhards will look in to this as a matter of urgency.</p> <p><b>Bungalows next to the school</b> – A resident who lives in a bungalow next to the school said that due</p>

	<p>to the trees, it is extremely dark and they require some work. Clerk will contact Orbit Housing Association to raise this concern.</p> <p><b>Salter's Oak Development</b> – A resident has asked the Parish Council to confirm whether or not the Open Market houses were all sold to people with a connection to the village. Whilst the Chairman believes this to be the case, the Clerk will seek clarification.</p> <p><b>Speeding in the village</b> – A resident has emailed expressing great concerns over the speed at which vehicles are driving through the village. All Councillors agreed that this is a very justified concern and residents attending the meeting also expressed concerns. Approx. 18 months ago, Cllr Millard tried to set up a 'speeding team' of volunteers to use mobile speed cameras throughout the village. Sadly, there was a lack of volunteers with only 5 people able to commit to this and since the minimum number required is 6, this was not able to go ahead. The Parish Council is very happy to explore this again but it will require committed volunteers. There are restrictions on when the cameras can be used. If anyone is interested, they should email <a href="mailto:greatalne.parishcouncil@googlemail.com">greatalne.parishcouncil@googlemail.com</a> or speak to Cllr Ian Millard. Volunteers are required to attend a training course on using mobile speed cameras and then commit to a certain amount of time.</p>
<p>COUNTY COUNCILLOR'S REPORT</p>	<p>County Cllr Rickhards used some of his delegated budget funds to request new signs on Alne Cote Corner. The drawings received were sent back to the Traffic and Safety team at WCC as the Councillors all felt that the 30mph speed limit needed to be moved to the Alcester side of the double bend. The Parish Council are now awaiting a new drawing for approval.</p> <p>County Cllr Rickhards also said there are discussions underway in Little Alne to extend the 30mph limit further.</p>
<p>DISTRICT COUNCILLORS REPORT</p>	<p>District Cllr Mrs G Forman was unable to attend the meeting. No report sent.</p>
<p><b>MATTERS ARISING</b></p>	<p><b>Huff Cap Update</b> – Since the last meeting, the sale of the pub sadly fell through. David Roffe (Operations Director) has been in contact with the lead representative for a local group interested in the future of the Mother Huff Cap. The group has asked to be given until the end of September to research the possibility of a bid from within the local community. The group will contact David to arrange a meeting if they wish to explore in detail the possibilities relating to the future of the pub. The site's owners have taken no action to progress any alternative options while they wait for the group's decision.</p> <p>Residents asked who the lead representative was but the Chairman felt it was not his place to disclose this. The Chair will however feedback to the relevant parties that the residents would like to be updated as soon as possible as they may be able to help.</p> <p><b>Emergency Committee</b> – The equipment stored at the Memorial Hall has not yet been checked (annual requirement) but the Chairman hopes to do this this week.</p> <p><b>U_Route Sernal – Coughton Fields Lane (AKA E5998)</b> – A meeting with the tree contractor, Chairman, Clerk, land owner (of adjacent field) and the police took place on Monday 22<sup>nd</sup> July to discuss the plan of action moving forward. It has been agreed that large tree trunks will be placed at both ends of the track as well as the middle. These will be sufficient in size to prevent vehicular access but will not block horse riders, pedestrians or cyclists. This does mean that motorbikes may still be able to access this but it wasn't felt suitable to block off access to horse riders. The quote for the work has been received and is £1271 inc VAT. Chairman to confirm with local residents who live close to the track if they are happy with this proposal.</p> <p><b>Annual Tree Survey</b> –Following the Tree Survey recently conducted by Limebridge Rural Services, a quote for all high and medium risk work was obtained. The total cost to address the 5 high risk and 9 medium risk trees was £480.00. This quote is based on a single site visit to carry out the work and includes removal and disposal of cuttings. Councillors were all in agreement that we should proceed with this quote. Clerk to instruct Limebridge to proceed.</p> <p><b>PFK Littlejohn LLP – Annual External Audit &amp; Internal Financial Check</b> – The external review of the Annual Governance and Accountability return has now been completed. The 'Notice of conclusion of audit' has been added to the noticeboard and Parish Council website. The Chairman thanked the clerk for her work on this.</p> <p>The clerk and Cllr Millard met on 9<sup>th</sup> September 2019 to complete the bi-annual internal financial check. No areas of concern.</p>

**General Maintenance Issues:**

- **Cricket Club Parking** – The County Council are happy for the layby to be cleared and used by the Cricket Club on an informal/flexible basis. This is on the understanding that it needs to be locked up after every meeting/event. Cllr Millard has asked Mr Moody to make every effort to ensure this is cleared before the start of next season. Clerk to ask Limebridge to quote to clear/tidy this layby annually (would be paid for by the Cricket Club).
- **Alne Cote Corner** – Cllrs waiting for new drawings from WCC showing the 30mph signs have moved to the Alcester side of the bend. Should have an update in November.
- **Damaged sign – Station House** – Westbound traffic sign near Station House was reported as it was in danger of falling down. County highways have removed the sign to make it safe and it will be re-erected on new posts in due course.
- **Pavements by church** – Ongoing concerns over the poor state of the pavements by the Church have been raised with county highways. They responded to say this work remains on the programme and they would arrange an interim inspection to see if any temporary repairs are required. They also said that whilst it looks bad, the pavements are in pretty decent condition structurally so should hold out a little longer. Councillors disagree with this. They explained the area is very poorly lit so even more of a concern early mornings and evenings and it is used a lot as serves both the Church and Memorial Hall. Clerk to go back to county highways.
- **Pavement – School Rd** – Cllr Clark notified the clerk that the pavement between 60 and 70 on School Rd has broken up. This has been logged with county highways.

**Adventure bike ride festival** – Following July’s meeting, the Clerk contacted Stratford District Council, Warwickshire County Council and Alcester South Police Team. Concerns were raised that residents were not notified in advance and that Stoa Lane and Park Lane are not suitable roads to have hundreds of bikes racing along. The replies were disappointing with not a great deal of responsibility being taken. Ultimately, it is the organiser of such events that hold responsibility for informing residents. The police have contacted the organiser ahead of next year to pass on our concerns about the lack of suitability of Park Lane for this event as it is due to run for 5 years. The Chairman will be responding to SDC, WCC and the Police to confirm concerns.

**Summer Newsletter** – All residents should have received their copy of the Summer newsletter. Please contact the clerk if you haven’t.

**Electricity – switched tariff** – The Parish Council have switched to a new tariff with EON which is a fixed term contract of 60 months. This should give a saving of approximately £300 per year. It includes a removed volume tolerance so should the consumption drop due to more efficient lighting (LED’s) we will not be penalised. EON will require the updated Unmetered Supply Certificate (this provides key information that is used by the electricity supplier) so the bill can be amended if we do switch to LEDs.

**MAIN BUSINESS**

PROGRESS AGAINST BUDGET

As of 1<sup>st</sup> September 2019, progress against budget stands at 50%. The repair for Karinya streetlight should come from the reserves account however so the true % of budget spent is 43% (£8013 spent/£18564 budget). To review again at November meeting.

RECREATION GROUND

The Clerk reported as follows:

Outstanding work completed since July’s meeting:

- Replace matting to RSS, double bay swings and new matting to area between Parcour and Toddler area gate
- RSS clean – power wash
- Removal ash branch at School Road entrance
- Toddler area – power wash

The Chairman and Cllr Clark visited the playground to inspect the work and are happy but have asked the clerk to raise the following with Limebridge:

- Repair damaged matting under Birds Nest Swing – doesn’t look like this has been done
- Express concerns with the quality of the seeding
- The grass on the northern boundary of the field has not been cut and has grown very

	<p>long – why is this?</p> <p>Residents from School Rd attended the meeting to request permission to cut the hedge that is between the recreation ground and their drive. They would also like to remove a branch from the Ash tree that is overhanging their drive. The Parish Council are happy for them to proceed with this work but ask that they ensure all cuttings etc are removed and not left in the recreation ground. They will contact Cllr Clark to arrange access to the park through the locked gate in order for them to remove the hedge cuttings.</p> <p>Fields in Trust have sent a sign for Great Alne to display in the park. This will be added to the existing pole at the park entrance. Clerk to contact Mr Prince to arrange.</p>																
ANNUAL PLAYGROUND INSPECTION	<p>The Annual Playground Inspection was completed by The Play Inspection Company on 15<sup>th</sup> August 2019. All of the risks they identified were either low or very low risk. Some action is required but due to the detail and length of the report it was agreed that the Chairman, Cllr P Clark and the clerk will meet at the recreation ground ahead of the November meeting to decide what action to take. Additionally, they will discuss the issues highlighted during the weekly playground checks including; the hole in the fence between the rec ground and Huff Cap car park, the broken panels in Austin Cottage fence and condition of the hedge/fence on the northern boundary. The intention is to obtain quotes for this work ahead of November meeting.</p>																
CHURCH YARD GRANT	<p>Gareth Roberts-Davies attended the meeting to request a grant from the Parish Council to go towards the upkeep of the churchyard. They have been having significant problems with their mower and have had to pay someone to do this which is proving very costly. They intend to put any money raised towards repairing or replacing the mower. The Councillors agreed to award a grant of £500 at this time but may be able to offer further funds later on in the year should the budget allow. Gareth thanked the Parish Council for this on behalf of the church.</p>																
ALLOTMENTS	<p>As mentioned in the Great Alne Park update, the allotments are now ready. There are currently 18 in total. The village of Great Alne have a 50% allocation of these but they will be managed by Great Alne Park. Estimated rental costs of £25 per plot per year. Please contact Kelly Webb if you are interested in having an allotment. 7 of the 9 assigned to Great Alne residents have already been allocated.</p>																
UBUS	<p>Stratford District Council have contacted all Town and Parish Councils reminding them that UBUS is a discretionary service that they are not statutorily obligated to provide, but they recognise the value of this service to people. They are asking Parish Councils for support in two ways: by advertising UBUS as much as possible and/or by making a small contribution towards the running costs of the scheme. Great Alne have 9 registered users. Councillors considered this and are happy to advertise further – noticeboards/newsletters etc but do not wish to make a financial contribution at this time.</p>																
STREET LIGHT REPAIR	<p>A street light on Park Lane was reported to Warwickshire County Council as not working. A contractor has inspected this lantern and advised that the lantern needs to be replaced; they are unable to repair due to its age and condition.</p> <p>The column and bracket are concrete, and WCC Street Lighting are unable to fit modern LED lanterns to this type of bracket. As a result, the column will need to be replaced. The estimated costs are £1,250 plus VAT to remove the existing concrete column and install a 5-metre steel column with 19W LED Lantern. Money has been reserved for these repairs and Councillors all approved the quote. Clerk to check if the pole can be wooden/something more aesthetically pleasing first though.</p>
