Crime Report

Thankfully, throughout 2020, crime in Great Alne has remained low. A regular update on crime within the area and useful information is issued by Warwickshire Police and can be found on their website https://www.warwickshire.police.uk/.

Door to Door Sellers

In recent weeks, the police have had several reports of men going door to door, trying to sell items from holdalls. The police have provided some information about this type of call.

It is unlikely that they are part of any prison or young offenders rehabilitation scheme. If they are, they will have official identification and will be happy to produce it. They should carry a Pedlars Certificate issued by the police area they live in. This certificate should be produced on request. If you have a seller at your door and you feel that they are not complying with the law or they are acting suspiciously then call the police straight away on 101 to report.

There <u>are</u> legitimate representatives that go door to door taking orders for new windows and building work etc. To prevent such calls, put a sign on or near to your door saying that door to door sellers are not welcome. If in doubt, do not answer the door. Consider using a video doorbell to monitor any callers.

Working together to keep safe

The Parish Council were pleased to be able to re-open the park on 20th July following the three-month closure. In order for the park to remain open, it is essential that social distancing and the rules advertised on the signs at the park are adhered to. As a reminder:

- 1. Please respect and maintain social distancing at all times, ideally keep at least 2 meters apart, and certainly no closer than 1 meter. If the play area is busy, please go back later or wait. We are unable to monitor the use of the playground but strongly recommend the following to ensure social distancing:
- a. Only one adult per child in the toddlers' area.
- b. Max of 3 children and 3 adults in toddler area at a time.
- c. Birds nest swing 1-person max at a time (unless the same family group)
- d. All other equipment max of two users at a time
- 2. The Parish Council does not have the resources to undertake cleaning of this equipment on a regular basis and ask that parents wipe down equipment before and after use.
- 3. Please use hand sanitizer for yourself and your child throughout your visit and ensure hands are washed thoroughly when you get home.
- 4. The attempts to secure one of the swings to prevent use have been undone. The Parish Council feel it is safer to leave the swings as they are but please only use one swing at a time to maintain social distancing.

Parish Council Update

The Huff Cap

The new owners have recently submitted their plans to Stratford-on-Avon District Council and these are publicly available by visiting the 'Planning' page of the Parish Council website. In brief, the proposals include the: "erection of 3 new dwellings, re-configuration of the public house car park and beer garden including demolition of modern garage".

Flooding

As winter approaches and the inevitable rainfall increases, concerns remain over flooding/drainage in lots of different parts of the village. At the end of last year, County Cllr Rickhards suggested that the Parish Council request a comprehensive survey from the Flood Risk Management Team. This was arranged for March 2020 but lockdown restrictions meant this meeting was cancelled. As restrictions eased, the Parish Council have tried to rearrange this survey. The Flood Risk Management Team have confirmed however that between Covid and a high number of internally flooded property investigations, they are struggling to meet expectations for many site visits. They would need to justify the expense of their specialist contractors attending to survey and so have asked County Highways to provide the most recent highway reports for the sections the Parish Council identified as key problem areas. An update will be provided at the November meeting.

Proposed changes to the planning system

The Government is proposing major changes to the planning system in England. The 'Planning for the future' consultation proposes reforms of the planning system to streamline and modernise the planning process, bring a new focus to design and sustainability, improve the system of developer contributions to infrastructure, and ensure more land is available for development where it is needed. The Chairman attended a briefing session on these proposed changes and updated the Councillors (at the September meeting) with the high-level information. More information will be available when the Government White Paper is issued. The consultation period closes on 29 October 2020, and comments will be shared after the Parish Council have considered the proposals in detail.

Creation of Unitary Authorities

A Government White Paper on local government reform is to be issued in the autumn. Among other things, this will include a review of the principal authorities which will probably lead to the creation of a unitary authority of some kind in Warwickshire which will combine the functions of County and District Councils. Our county may be fast tracked and it could all happen in the next two to three years.

The government wishes to strengthen the role of local councils and other community governance arrangements. This might lead to significant changes for Parishes such as gaining control over services with money, staff and training. It may also be advisable for parishes to collaborate voluntarily together to have enough influence to be able to negotiate with the unitary authority.

There are currently two possible options being floated: a single unitary council for Warwickshire which would in effect combine the functions of the County Council and the Districts, or two unitaries, one each for the north and south of the county. Further details will be provided as more information becomes available.

Great Alne Park Update

Jeremy Conen, Senior Development Manager for Inspired Villages has sent the following report.

"General Progress

Our contractors, Seddon, are making good progress with the next phase of cottages. They have adopted the industry approved working practices to keep everyone safe and this has had a slight delay in allowing progress. We are also experiencing supply issues with some materials. We hope to have the next phases of cottages complete in November and December. The two apartment blocks are due to finish before the end of the year subject to the impacts of the pandemic.

Events

The events programme for this year have been suspended due to the Covid outbreak.

Hoarding

It is still our intention to replace the hoarding on Henley Road and complete the landscaping works and install the signage previously shared with you. Our board requested further information on costs and feedback from our own residents which will be presented for approval this month. Once approved we will be able to progress a planning application followed by the implementation.

East Entrance

Whilst for marketing reasons we want to open the east entrance as soon as possible, our safety advisers are very concerned at the risk of residents and heavy construction traffic coming into conflict. This is especially a concern due to the heavy earthworks required to complete the foundation excavations for our third phase. The material excavated needs to be transferred across to the meadow where it will be shaped and landscaped. We are currently reviewing the programming of these works with planning officers and will be engaging county highways in these discussions.

Phase 3

We are still working with the local planning authority on our proposals to change the type of units we want to build in our third and final phase at Great Alne Park. Our objective is to introduce smaller and more affordable units into the scheme. This appears to be supported by the local authority, although there are some challenges, we need to work through with them around the Community Infrastructure Levy and affordable housing contributions. Our aim is to have a planning application ready to submit in December 2020. We will share our plans with the Parish ahead of any submission.

Farm Shop and Medical Centre

Work is underway with the conversion of the former sales centre to convert this into the new medical centre. We hope to be able to handover the property to Alcester Healthcare in December 2020.

We have also placed the contract to fit out the thatched building which will operate as the village shop. We have identified a local business who will be operating the shop as a farm shop. We hope this will open in the first quarter 2021."
