# Traffic calming

The results of the recent speeding survey show that speeding is still a serious issue in certain parts of the parish, particularly near Great Alne-Primary School. The data, which was commissioned by Inspired Villages Group on behalf of the parish, has been sent to Warwickshire County Council's Highways Dept (WCC) for analysis.

The next step involves working with WCC to consider and install traffic calming measures in the worst affected locations. These things always take considerable time, but we will keep you posted with developments.

# **Flooding issues**

Flooding has been a serious problem across the region as well as Great Alne this winter. GAPC's volunteer Flood Action Group (FIAG) had its first meeting in January and some of the team have already undertaken basic training.

The team is currently working on referencing the drains for allocation amongst the volunteers, and, where safe to do so, they will help with keeping their drains clear of debris and silt. They will also assist with reporting flooding and drainage issues to WCC and providing an emergency response to residents, if and when required.

GAPC has also been working with WCC to create a list of jobs required on highways and gullies, including regular clearing, jetting and drain capacity. We also have the support of Warwickshire Wildlife Trust in assessing and delivering Natural Flood Management on the tributaries of the River Alne. Local farmers have also been very supportive and, following a recent meeting, are working with GAPC to address some of the concerns around ditches and specific problem areas. We are also in touch with Severn Trent to see what help and solutions they might be able to provide.

There clearly isn't one solution to the flooding issues, but GAPC is hopeful that a multi-angled approach will help alleviate and mitigate the problems and ensure that at lease the main route to Alcester is accessible at all times. ## Ultrafast Full Fibre Broadband in Great Alne

At the last parish council meeting, Robert Rowan, Partnership manager from Openreach, confirmed that Great Alne has reached the required number of households pledging support for the Openreach Fibre Community Partnership (FCP) scheme. This means the parish will benefit from the installation of Fibre to the Premises broadband connection which is not only very fast but also more reliable. There is more information from CSW here

# **COMMUNITY ACTION DAY**

GAPC is hosting a Community Acton Day on **Saturday 2 March 2024**, **10am-2pm** at the Great Alne and Kinwarton Memorial Hall, Henley Road B49 6HL. This is an opportunity for you to meet and ask questions with a number of local organisations and services including, among others:

Residents will have the opportunity to seek advice and support from experts on energy, home safety, local policing, local health and social care services, home security, our local primary school, our churches, local environmental issues and much more. You can visit the stands and ask questions and be sign posted to support locally. You will also have an opportunity to comment on possible sites for affordable homes in Great Alne with the WRCC.

During the event, you will be able to access the new *crime prevention tool box* of which the parish council will become custodian, courtesy of the Rural Crime Advisers. This contains: window vibration alarms, property marking kits, faraday pouches, van alarms, shed alarms, property marking pens, TV simulators, personal alarms, switch timers, and much more.

There will be refreshments available throughout the event. Subject to its being needed elsewhere, it is hoped that there will be a fire engine outside the Memorial Hall for residents to investigate at close quarters!

The event will be followed by the Parish Assembly from 2-3pm which is a further opportunity for residents to come together and find out more about what is available in the local area and hear about the parish council's plans for the year ahead.

The Community Action Day is free to attend and we are certain there will be something of benefit for everyone in Great Alne.





## **CLIMATE ACTION UPDATE**

The Climate Action Group will be available at the Community Action Day to discuss plans and ambitions for the year ahead.

With new funding available, the volunteers are keen to speak to residents about the results of the 'Making Great Alne Greener' survey and how this has enabled the group to prioritise resources for key projects. These include flooding issues, active travel, planting of a community orchard in the Recreation Ground next autumn (plus water provision for the new trees), looking into an electric vehicle charging point for the parish, rewilding verges and working with School on climate action projects. The Group is also planning a 'Community Swap Event' later in the year.

#### FOOTPATH SURVEY

A new working group of volunteers has been established to undertake a survey of the footpath network across Great Alne. Once completed, the group will be able to work with WCC and the Community Pay Back Team to address issues along the surface of the paths as well as signage. GAPC will liaise with relevant landowners regarding other factors affecting access or the condition of the paths or crossing points. # Fire service changes

A series of information sessions have been set up to consider proposed changes to the service delivery model of the Warwickshire Fire and Rescue Service. # Dogs in the Recreation Ground

A number of residents have asked for clarification on the current signage regarding dogs in the recreation ground. The issue has been discussed at the last two GAPC meetings and after considered debate, the councillors have decided that on a trial basis, dogs will be allowed to go through the park but only on condition that they stick to the existing footpath from the Nightingale Close entrance to the Henley Road entrance. Dogs must be kept on a short lead at all times and are not allowed on the grass under any circumstances.

A group of local residents, all of whom are dog owners, will observe how well this rule is adhered to for the next few months. If the rule is flouted, the GAPC will introduce an absolute ban on all dogs in the recreation ground, even as a thoroughfare. Thank you for your cooperation.

# NEW HEAD AT GREAT ALNE PRIMARY

## : Community Shop

GAPC is delighted to welcome Matthew Penn as the new headteacher of Great Alne Primary School. Mr Penn took over at the school in December 2023. He has been in teaching roles for the past 20 years, including seven years as deputy head at Thomas Jolyffe Primary School in Stratford.

Mr Penn recently told The Stratford Herald: "I'm all about creating a safe and calm environment for people to work in and for children to learn in, where other people feel welcome, so it has been fantastic to feel welcomed by all of the people over here already." Music at the school is just one of the attractions for the new headteacher and keeping Great Alne immersed in music is one of his aims. "I could see that the school is an absolute festival of music. There's an abundance of creative and musical staff who are just really committed to making the children have a good time and a good education." Mr Penn is a keen pianist outside of work, and as well as spending time with family – he has two children with his wife Caroline - he also enjoys playing table tennis, golf, darts and snooker. We wish him every success in his new role, and he has the full support of GAPC in achieving his objectives at the school.

# **Councillor vacancy**

GAPC is seeking to co-opt a new Member to join the team of parish councillors. The term of office will last until May 2027, when all Members must be re-elected. Applications in writing, together with a brief statement of reasons why you wish to be a Councillor, are invited from any parishioner who feels they could contribute to the working of GAPC and who is keen to be involved in shaping their community's future. No experience is necessary, and training is available.

A candidate for a parish or town council is qualified if, when nominated:

- he or she is a British citizen, a citizen of any member state of the European Union or an eligible Commonwealth citizen
- is over 18 years of age
- is either in the list of electors for that parish or town or has during the whole of the preceding twelve months:
- occupied land as owner or tenant in it; or
- had a principal place of work there; or
- resided in or within three miles of it.
- And is not disqualified from holding office as a Councillor.

Applications should be emailed or posted before the closing date of **26 February 2024** to the Clerk (contact details overleaf).

A new community shop will be opening in April/ May in Great Alne Park.

The shop will be run by volunteers from the Retirement Village and the wider community of Great Alne. The operators are very excited about the project, even though it has taken longer than anticipated to get off the ground.

The opening hours are still to be confirmed but will hopefully be 9am - 11am and 3pm - 5pm, Monday to Friday; and 9am - 12pm on Saturdays.

Payments will be debit card only.

The intention is to source local products such as honey, bread and eggs where possible. Alongside basic groceries i.e. tea, coffee, dairy products and tinned foods, there will be a limited stock of beer and wine.

The team are working on sourcing a fresh fishmonger to come once a month. Other items for sale include cards, postage stamps and wrapping paper.

The operators of the shop are keen to serve the whole community, so if there is anything you would like the shop to stock, please ask and the team will try to accommodate you.

We will keep you posted when the opening date is confirmed. The team look forward to seeing you soon!
