

## **How to submit your comments on the SWLP to Stratford District Council (SDC)**

SDC prefers any comments to be submitted via the online portal. Here are the steps to do this:

1. Go to the main page <https://www.southwarwickshire.org.uk/swlp/preferred-options.cfm>
2. Click on Option 1 – ‘Preferred Options Consultation’:

3. Under the ‘How to View and Comment’ section – click on the blue link ‘Preferred Options Consultation Portal’.
4. This will open to a page headed ‘Preferred Options 2025’.

5. Click on the + sign to the right hand side of Chapter 4 – ‘Meeting South Warwickshire’s Sustainable Development Requirements’.
6. A drop-down list of subsections appears. Scroll to Section 4.1 and the third green link down– ‘Do you have any comments on a specific site proposal or the HELAA results?’
7. Click on the link and it brings you to this pink box:

**Do you have any comments on a specific site proposal or the HELAA results? (please include site name and reference number as identified on the [interactive map](#)).**

8. When you are ready to comment, click ‘Comment’ button. You will need to create an account using your email address and need to provide your name and home address. You can then submit your comment.
9. You will need to provide the site reference which you will find by clicking on the relevant Great Alne site on the interactive map here:

<https://soadc.maps.arcgis.com/apps/webappviewer/index.html?id=5a3b9976bd7749a3bff44b2a1016ffc4>. In summary:

- Site 620 – Land off School Road
- Site 757 – Land adjacent to the B4089
- Site 880 – Land to the north of the B4089
- Site 133 – Land off Sernal Lane
- Site 650 - Land to the east of Sernal Lane and Appleby Close

10. You will need to submit a new 'Comment' for each site or policy you wish to make a submission on. Therefore, if you wish to comment on all 5 sites in Great Alne, you will need to complete a new 'Comment' form for each site.
11. You can submit 100 words in the comment box but have the option to attach up to 4 x 20MB files by way of further documents or additional information.

Please note that your name (but not your email or home address) will appear with your comment on the comments page of the SWLP website. Please read the privacy information on the SWLP website.
